

SWÖSU Student Participates in International High Performance Computing Competition



SWOSU Computer Science Senior, Prabhjyot Singh Saluja, participated in the 2017 student cluster competition at The International Conference for High Performance Computing, Networking, Storage and Analysis, SC17 in Denver, Colorado. Other competitors participating in the event included Harvard University and institutions from Poland, Germany, Japan, and China.

During the competition, Singh focused on running the Born application. Born is a seismic image rendering program developed at Stanford. Saluja was on a combined team with five

students from San Diego State University (SDSU). The partnership was formed through the NSF-funded Advanced Cyber Infrastructure Research and Education, Facilitator Virtual Residency.

SWOSU Assistant Professor, Dr. Jeremy Evert, played a key role in forming the SWOSU/SDSU team. "The competition provides Singh the chance to work with some of the best minds in the world. Everyone had a great experience and walked away with valuable skills for their resumes," said Evert, who served as assistant mentor for the team.

"We are proud to support our other undergraduate researchers. Singh's contribution at the international competition is a great reminder of what SWOSU students can do," said Dr. Patsy Parker, Associate Dean of the Everett Dobson School of Business and Technology. She added, "Dr. Evert's enthusiasm and love of research has been a huge asset to our computer science program. The program has increased enrollment and much more involvement in research since he joined the faculty team."

Web site: National Endowment for the Humanities **Synopsis:** The goals of the Institutes for Advanced Topics in the Digital Humanities program are: (1) to bring together humanities scholars and digital technology specialists from different disciplines to share ideas and methods that advance humanities research and teaching through the use of digital technologies; (2) to reflect on, interpret, and analyze new digital media, multimedia, and text-based computing technologies and integrate these into humanities scholarship and teaching; (3) to build communities of inquiry and contribute to the intellectual vitality and professional development of participants; (4) to teach current and future generations of humanities scholars to design, develop, and use digital tools and environments for scholarship; and (5) to devise new and creative uses for technology that offer valuable models that can be applied specifically to research in the humanities, and to allow those methodologies and approaches to be shared with humanities scholars and teachers. The National Endowment for the Humanities strongly encourages applicants to develop proposals

for multidisciplinary teams of collaborators that will offer the necessary range of intellectual, technical, and practical expertise. The program is designed to bring together humanities scholars, advanced graduate students, librarians, archivists, museum staff, computer scientists, information specialists, and others to learn new tools, approaches, and technologies and to foster relationships for future collaborations in the humanities. Grants support national or regional (multistate) training programs. **Funding Range**: \$50,000 to \$250,000 in outright funds for one to three year grants.
