Compliance Corner: BIOSAFETY

The Institutional BioSafety Committee (IBC) is appointed to review all research, funded or unfunded, conducted on the SWOSU campus involving the use of **potentially infectious organisms and/or recombinant DNA** to ensure proper safeguards are instituted in order to protect the health of the employee and the environment. All faculty or staff wishing to conduct such research are required to complete a BioSafety Compliance Form located on the SWOSU web site at <http://www.swosu.edu/administration/osp/research-forms.asp> and receive approval prior to the initiation of new research projects. Once approved by the IBC, continuing research projects do not need to be reviewed in subsequent years unless alternative host systems, vectors, or protocols are employed. Completed BioSafety Compliance Forms may be submitted to Anita Blankenship, Director of the Office of Sponsored Programs.
