CONDUCT AGREEMENT

Please read the rules for SWOSU Intramural Sports set forth below and sign at the end acknowledging you have read said rules.

The mission of intramural sports at SWOSU is to provide an enjoyable, engaging experience for participants and for referees alike. Any disrespect or threats toward other players or refs will be punished accordingly. It ruins the intramural experience for everyone involved. **The SWOSU Wellness Center Manager/Director reserves the right to suspend intramural activities at any time if it is deemed that referees or other students are threatened or disrespected in any manner.**

- Players must treat each other and the referees with respect.
 - The person/signee will be responsible for his/her own conduct.
 - Everyone is expected to have a certain degree of maturity.
 - We will not tolerate any outburst of any violent aspect.
- ***Profanity*** is not a part of higher learning. With that in mind, if language is getting out of hand, Wellness Center staff will warn the offending individual(s), and if it does not stop, the individual(s) will be asked to leave the premises.
- ***Alcohol/Drugs***, in the SWOSU student handbook, you will find that alcohol and/or drugs are not permitted on campus, nor at any school sponsored activity off campus. i.e. any Wellness Center sponsored activities/ intramurals.
- **Violation of this Conduct Agreement:**
 - The first thing that will happen is to ask the offending individual(s) to leave the premises. If the individual(s) in question do not willingly leave, Wellness Center staff will contact campus police for them to deal with the individual(s).
 - If the individual refuses to leave willingly, his/her team will forfeit the game and SWOSU Police will be called to escort the individual out of the facility.
 - Any player found to continually violate the Conduct Agreement is subject to such punishments including, but not limited to, further game bans or disqualification from ALL SWOSU intramural sports from the next 12 months.
